Girls & young ladies ages 4 years to 24 years old. Age for the 2026-27 School Year

Must be attending school, college, be home-schooled, or in a Head Start program.

- Girls ages 4 - 11 years old - Must have cultural attire and an evening gown for the event.

\$25 Entry Fee, per contestant - **Must be paid by April 1, 2026.**

- Girls ages 12 - 24 years old - Must have cultural attire and an evening gown for the event. Must write a one-page essay on "What it means to me to be Hispanic in the United States".


\$100 Entry Fee, per contestant - **Must be paid by April 1, 2026.**

8. No Flash photography - please take all the photos and videos you like, but without Flash or lights, as it disrupts our paid Photographers and Videographers. We will ask you to refrain from any more videos or photography if you do not follow these directions.

9. Contestants must attend mandatory practices. Parents must make reasonable accommodations to attend training and practices.

10. Miss Princesa Hispanic Heritage will begin at 1:00pm, girls must arrive before 12pm.

11. Miss Hispanic Heritage will begin at 5pm. Girls must arrive before 3pm.

12. There is limited space in the dressing room, it is advised to have hair and makeup done before arriving to the event.
